

Early Childhood Teacher Registration



ACECQA approved qualifications will now be accepted for teacher registration in South Australia.

Current National Framework for Teacher Registration

The National Framework for Teacher Registration is a nationally consistent framework for the registration of teachers in all states and territories in Australia. Only registered teachers may be employed to teach in schools and early childhood settings.

The National Framework currently provides a minimum qualification requirement for registration as completion of at least four years of higher education (full-time or equivalent) study, including an initial teacher education program accredited in Australia; or an overseas qualification assessed as equivalent.

From 6 June 2024, early childhood teachers who have graduated with an Australian Children's Education and Care Quality Authority ('ACECQA') qualification – with focus upon 3-year birth-to-five bachelor degrees - will be eligible to be registered as a teacher providing education in an early childhood setting in South Australia.

Please Note: ACECQA approved qualifications **not** accepted are: Graduate Diplomas and Graduate Certificates

Royal Commission into Early Childhood Education and Care

The South Australian Premier and the Minister for Education, Training and Skills supported the 43 recommendations of the Royal Commission into Early Childhood Education and Care in January 2024.

The *Teachers Registration and Standards Regulations, 2024* have been amended to support minimum qualification requirements for early childhood teachers holding an ACECQA approved qualification.

Teacher registration under the new requirements will be limited to providing education in early childhood settings. This will be clearly marked on the Certificate of Registration and noted on the Public Register.

The Condition states:

The holder of this registration is restricted to providing preschool education to children who have not yet attained the compulsory school age at a preschool, a preschool program delivered in a school separate from children who are receiving an education program for compulsory school aged children, a centre-based long day care and out-of-school hours care service.

What this condition means

A teacher with this condition on their Registration is limited to teaching in early childhood services including preschools, kindergartens and long day care settings.

Early childhood teachers involved in provision of a dedicated education program, in an out-of-school hours care setting, should also be limited to providing birth-to-five, or early childhood education.

Under s24 of the *Teachers Registration and Standards Act, 2004* (the Act) - Conditions of Registration, the Board may impose conditions of registration which may include the following:

- conditions requiring the education that the person may provide (in this case, the education is restricted to early childhood centres, pre-schools, kindergarten, and Out-of-school aged care for prior to compulsory school-aged children).

How do I apply?

By reference to your completed ACECQA approved qualification, you may apply using the standard application for teacher registration, fill in the **form**, provide proof of your qualification, pay a teacher registration fee and undergo the usual fitness checks. You will then be registered. A Certificate of Registration including the condition will be issued and the Public Register of registered teachers will advise others of the condition effect.

Compliance with conditions of registration

Registered teachers must comply with conditions of registration. A person's history of compliance with conditions of registration is also a relevant factor in fit and proper considerations at the time of renewal of their registration.

Conditions of registration are also relevant for employers, who should check the Public Register to ensure they do not appoint, employ, engage or give permission to a registered teacher to teach at an educational institution in contravention of a condition, including where limited to providing education in an early childhood setting.

What if I'm studying a 4-year accredited qualification (whether birth-to-8, or birth-to-12 studies?)

You can continue your studies. You can seek registration as a teacher, but not limited to providing education in an early childhood setting. This condition will not apply to you. You will apply for teacher registration and once granted, be eligible to work across the sectors.

If I'm part way through an early childhood qualification and hold a Special Authority to Teach, can I stop at the 3-year equivalent point of study?
